The Statute governing the terms and conditions of the Vice Chancellor and Pro-Vice-Chancellor of the Universities of Bihar, 2019

Statute governing Terms & Condition of Vice Chancellor and Pro-Vice Chancellors of all Universities of Bihar except Bihar Agricultural University, Sabour and Bihar Animal Sciences University, Patna is framed under Section 10(4)(1) & 12(2) of Bihar State Universities Act, 1976, Section 11(4)(1) & 14(2) of Patna University Act, 1976, Section 11 and 13 A of the NOU Act, 1995 and Section 10 (6) of Aryabhata Knowledge University Act, 2008.

After due consideration of the recommendations of the three Vice-Chancellors Committee constituted vide notification no. **BSU-33/2014-991/GS(1)**, dated 19.07.2014 and opinion rendered by all Universities of Bihar and the Department of Education, Bihar, Patna vide its letter no. 15/M 1-75/2015-728, dated- 26.03.2019 and in exercise of the powers conferred upon him under section 36 of the Bihar State University Act, 1976 and Patna University Act, 1976, and other relevant provisions of NOU Act, 1995 and Aryabhata Knowledge University Act, 2008 the Hon'ble Chancellor of Universities of Bihar has been pleased to approve the Statute for fixation of the terms and conditions of the Vice Chancellor and Pro-Vice Chancellor for all Universities of Bihar except Bihar Agricultural University, Sabour and Bihar Animal Sciences University, Patna.

Short title, extent and commencement

The Statute shall govern the terms and conditions with regards to facilities extended to **Vice Chancellor** under **Section (10) of Bihar State Universities Act, 1976, Section (11) of Patna University, Act, 1976, Section (11) of Nalanda Open University Act, 1995 and Section (10) of ~~Aryabhatta~~ Knowledge University Act, 2008 and Pro-Vice-Chancellor under Section 12 of BSU Act, Section 14 of PU Act, 1976 and Section 13 A of NOU Act, 1995 as amended up-to-date.**

1. This Statute shall be called The Statute for Terms and Conditions of the Vice-Chancellor Section (10) of Bihar State Universities Act, 1976, Section (11) of Patna University, Act, 1976, Section (11) of Nalanda Open University Act, 1995 and Section (10) of ~~Aryabhatta~~ Knowledge University Act, 2008 and Pro-Vice-Chancellor under Section 12 of BSU Act, Section 14 of PU Act, 1976 and Section 13 A of NOU Act, 1995 as amended up-to-date.

1.1 It Shall apply to the Universities recognized under **Section (10) of Bihar State Universities Act, 1976, Section (11) of Patna University, Act, 1976, Section (11) of Nalanda Open University Act, 1995 and Section (10) of ~~Aryabhatta~~ Knowledge University Act, 2008 and Pro-Vice-Chancellor under Section 12 of BSU Act, Section 14 of PU Act, 1976 and Section 13 A of NOU Act, 1995, as amended up-to-date.**

1.2 It shall come into force with effect from the date of issue of notification.

2. **Definitions-** In this Statute, unless there is any thing repugnant in the subject or context.

2.1 "Statute" means the Statute for Terms and Conditions of the **Vice Chancellor** under **Section (10) of Bihar State Universities Act, 1976, Section (11) of Patna University, Act, 1976, Section (11) of Nalanda Open University Act, 1995 and Section (10) of Aryabhata Knowledge University Act, 2008 and Pro-Vice-Chancellor under Section 12 of BSU Act, Section 14 of PU Act, 1976 and Section 13 A of NOU Act, 1995** as amended up-to-date.

2.2 "State Government" means the Government of Bihar.

2.3 "University" is as defined under **Bihar State University Act, 1976 of Patna University, Act, 1976, Nalanda Open University Act, 1995 and Aryabhata Knowledge University Act, 2008 as amended up-to-date.**

2.4 "Vice-Chancellor" means a distinguished academician duly appointed as Vice-Chancellor by the Chancellor of Universities of Bihar under the provision of **Section (10) of Bihar State Universities Act, 1976, Section (11) of Patna University, Act, 1976, Section (11) of Nalanda Open University Act, 1995 and Section (10) of Aryabhata Knowledge University Act, 2008. Pro-Vice-Chancellor means a distinguished academician duly appointed as Pro-Vice-Chancellor under Section 12 of BSU Act, Section 14 of PU Act, 1976 and Section 13 A of NOU Act, 1995** as amended up-to-date.

2.5 "Terms and Conditions" mean terms and conditions fixed by the Chancellor of Universities of Bihar for the services of **Vice-Chancellor and Pro-Vice-Chancellor of the Universities of Bihar** in consultation with the State Government.


2.6 "Pay Scale" means the scale of pay sanctioned by the State Government and revision from time-to-time as sanctioned by the Government.

3.0 **Facilities:** "Facilities" means facilities extended to the Vice-Chancellor and Pro-Vice-Chancellor regarding provision of a residence, vehicle with driver, electricity and water.


3.1 Well furnished free house/ quarter is to be provided by the University. In case, the University is not in a position to provide a well-furnished housing facility, then the Vice-Chancellor/ Pro Vice Chancellor may reside in his own house or a rented house. However, the rent amount should not exceed the House Rent Allowance (H.R.A) admissible for different categories of work place to H.A.G. officers of All India Service.

3.2 Dearness Allowance as admissible in the State Government.

3.3 The Vice-Chancellors / Pro-Vice-Chancellors will be allowed Air Fare in the class admissible to the officers of HAG of All India Service Officers working in the State.

- 3.4 The Vice-Chancellors / Pro-Vice-Chancellors will also be entitled to avail air fare including Boarding/ Lodging and transportation facilities as admissible to HAG officers of A.I.S. working in the State in case he/she is invited for any academic/ official work inside and outside India. However, prior permission will be required from the Hon'ble Chancellor of the Universities of Bihar in all cases, and of the State Government in case of visit outside the country. In case of an approved official overseas trip, an allowance shall be admissible at U.G.C. rates. There cannot be more than two overseas trips with the financial support of the University or the U.G.C. in a financial year.
- 3.5 The Vice-Chancellor/ Pro-Vice-Chancellor will be paid hotel and halt expenses, taxi charges as per State Government rules as admissible from time to time to HAG Officers.
- 3.6 **P.F contribution:** The University will pay provident fund contribution as admissible to officers of State Government.
- 3.7 Electricity & Water supply by the University, as admissible to H.A.G. officers working in the State.
- 3.8 Staff car facility with fuel and driver will be admissible. In case of non-availability of vehicle, it may be hired at the rate fixed by the Bihar State Tourism Development Corporation.

- 3.9 **Sumptuary allowance:** Sumptuary allowance as fixed by State Government.
- 3.10 **National Pension System:** Facility of contribution of National Pension System (NPS) @ 10% of Basic Pay + D.A. will be provided by the University, only to such Vice-Chancellors who were working at the source University under N.P.S. Vice-Chancellor / Pro-Vice-Chancellor under N.P.S. Scheme will further not be entitled for clause 3.6 benefits.
- 3.11 In case the incumbent Vice-Chancellor/ Pro-Vice-Chancellor is not a superannuated Professor, he/ she shall be entitled for pension contribution as per the rule of parent University/ Institution. However, the University/ Institution has to furnish a copy of the rule/ regulation of the concerned University.
- 3.12 **Leave:** All kinds of leave as provided in the Statute for University employees in the concerned University. Leave of Vice-Chancellors will be granted by Hon'ble Chancellor and leave of Pro-Vice-Chancellors will be granted by the Vice-Chancellor of the concerned University.
- 3.13 **Leave Calculation:** Earned Leave Calculation is admissible as per University rule.
- 3.14 **Medical reimbursement:** Medical reimbursement as per the rules applicable to All India Service Officers working in the State.

- 3.15 Leave of Absence from HQ : Permission will be sought from the Hon'ble Chancellor before leaving Headquarters for the Journey outside the territorial jurisdiction of the University as per Governor's Secretariat letter BSU-27/2013(Part-II)-949/GS(1). Pro-Vice-Chancellor will seek permission from their Vice-Chancellor.
- 3.16 Free telephone cell Phone and internet facility will be admissible equivalent to H.A.G. Officers of All India Service posted in the State Government.
- 3.17 **Duty Leave:** In a Calendar year, sixteen days of Duty leave is permissible.
- 3.18 **Foreign Visit:** Foreign leave will be granted by Hon'ble Chancellor but permission for foreign visit has to be obtained from State Government. Vice-Chancellor should request for grant of leave for foreign visit after obtaining the permission of State Government.
