Eligibility (A / B)

A.

- i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Mechanical/ Electronics/ ECE/ EEE/ Material Science / Basic Sciences/Nanotechnology / concerned / relevant / allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 / 2018 and their amendments from time to time as the case may be exempted from NET/SLET/SET :

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions :-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note:

- (i) Ph.D. thesis/subject must be well connected to the area of Nano science/Nanotechnology.
- (ii) The fulfilment of these above conditions (a to e) is to be certified by the Registrar or Dean (Academic Affairs) of the University.
But, the UGC Regulation 2009 has been notified by the Raj Bhavan in Bihar State in November, 2012 and it was implemented by the Universities of Bihar on different dates. Note: NET/SLET/SET shall not be required for such Master's Programs in disciplines, for which NET/SLET/SET is not conducted by the UGC, the CSIR or a similar test accredited by the UGC.

The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Desirable Qualifications:

- (a) He/She concentrate on Teaching & Research, in the area of Nano Science/Nano Technology.
- (b) Publications of at least 10 research papers related to multidisciplinary area of Nanoscience/Nanotechnology in the respective field in peer reviewed Journals as a author/co-author
- (c) Demonstrative leadership in organizing National/State level seminars/conference/academic activities.
- (d) Demonstrative leadership of handling high end research equipment like Electron Microscope, Vibrating sample Microscope, Fourier Transform Infrared spectroscopy and other Nanomaterials characterization equipments.
